## DAYTON INTERNATIONAL FESTIVAL 2026 INSURANCE

The Dayton International Festival carries three insurance policies:

- General Business policy
- Directors and Officers policy
- Liability Insurance policy for A World A'Fair

These policies are obtained through **Ferneding Insurance** [Ryan D. Mangin, 5540 Far Hills Ave., Dayton, OH 45429; (937) 294-1755, [RyanM@Fernedinginsurance.com](mailto:RyanM@Fernedinginsurance.com)].

The Greene County Fairgrounds requires DIFI to supply a certificate of liability insurance for the event, naming Greene County Agricultural Society DBA Greene County Fairgrounds as additionally insured. The "event" includes not only the Friday-Sunday event, but also set-up and take-down surrounding the event.

In preparation for the 2026 Dayton International Festival, **we need to be sure that all participating countries have \$1 million Liability Insurance coverage**. Please fill out and return the attached form at the January 4, 2026, meeting, or send your completed form to Don Hayashi, DIFI Insurance Coordinator. Please do this by January 15<sup>th</sup>.

**You can obtain the required insurance in one of two ways:**

1. If your organization **does not** have its own Liability Insurance, DIFI can obtain coverage for your organization. The insurance company will prepare a completed application for you to sign.
2. If your organization has its own Liability Insurance policy, you can get a certificate of liability insurance from your insurance company to meet this requirement.

Here is the information needed for the insurance certificate:

- **\$1 million** of liability insurance coverage.
- Event: **A World A'Fair held April 29-May 5, 2026, at Greene County Fairgrounds.** (dates allow for set-up, take-down)
- Name of Additionally Insured:
  - **Dayton International Festival, Inc. A World A'Fair, P.O. Box 384, Dayton, Ohio 45404-0384**
  - **Greene County Agricultural Society DBA Greene County Fairgrounds, 120 Fairground Road, Xenia, OH 45385**
- If you are serving alcoholic beverages, certificate must show **Liquor Liability** coverage.
